A SECOND JBJ SOUL KITCHEN OPENED IN MAY 2016 IN TOMS RIVER, NEW JERSEY, AS PART OF THE B.E.A.T. CENTER, A UNIQUE, COLLABORATIVE EFFORT WITH OTHER NONPROFITS. THE COMMUNITY KITCHENS HAVE SERVED OVER 114,000 NUTRITIOUS, DELICIOUS MEALS SINCE THEIR INCEPTION AND MOST RECENTLY SERVED 63% IN-NEED DINERS AND 37% PAYING DINERS. PAYING DINERS CAN AFFECT CHANGE BY PAYING MORE THAN THE SUGGESTED MINIMUM DONATION BY "PAYING IT FORWARD". FOR THOSE WHO ARE UNABLE TO MAKE A DONATION FOR THEIR MEAL, THEY ARE INVITED TO COME IN, ENJOY A MEAL AND LEARN HOW THEY CAN BE PART OF THE JBJ SOUL KITCHEN COMMUNITY BY VOLUNTEERING.
